Introduction

Each section is responsible and accountable for the behavior of its members and for the peace, order, and tidiness of the assigned terrains. Each group is also jointly responsible for the behavior at the subcamp and the entire site, also during activities that take place outside the grounds and water of Dutch Jamboree 2020.

The subcamp leadership ensures that groups and their leaders also comply with this.

These camp rules apply to all participants and staff members.

General Camp Rules

Arrival and departure

Not all participants can arrive at the same time at the grounds. A schedule is drawn up for this. All participants adhere to the times and guidelines for the arrival. Upon arrival at the subcamp, the group is allocated a place per section. It is not allowed to pitch your tent in any other place. Cubs are at the cubs subcamp (welpen subkamp), scouts at the scout subcamp (scouts subkamp), venture scouts at the venture scout subcamp (explorer subkamp).

Within the sub-camps, diversity will be at the top regarding placement; there is no classification based on region or country, a scattered classification is applied as much as possible.

Before departure, the subcamp staff checks the campsite in the presence of the participants. Damage to the terrain and/or materials from the Dutch Jamboree 2020 / Scouting Nederland will be recovered from the group responsible.

2. Camping space

The subcamp staff makes a site plan per subcamp. If you want to take large tents or awnings with you, consult this beforehand with the subcamp staff, so that space for this can be made available. Each group is given enough space for the specified section to set up the camp.

3. **Digging and open fire**

It is not allowed to dig anywhere on the grounds. Open fire and barbecuing is not permitted.

4. Sanitation

There are separate sanitary facilities (toilets, washrooms, and showers) for boys/men and girls/women. There are sanitary facilities for the disabled on site. Doing natural needs in places other than the toilets is not permitted. The use of these facilities is done in such a way that everyone can use it in a normal way.

To keep all sanitary facilities clean, all groups help with cleaning. A schedule will be made for this.

5. Night's rest

Amplified / mechanical noise is not permitted after 10 p.m. Absolute silence will be kept between 11 pm and 7 am and applies to the entire site, including the sub-camps of the scouts, explorers, and staff members unless the program states otherwise. Absolute silence applies from 22:00 to 07:00 for the cubs subcamp.

All participants and employees sleep in their own subcamps in a tent. Sleeping at heights is not permitted on all subcamps. It is also not allowed to sleep on a ship or your own vessel. In exceptional cases, permission can be granted to sleep in a replacement camping equipment. Requests for this can be made, with motivation and medical proof, and be submitted via info@nj.scouting.nl. Requests are assessed by the Production heads.

6. Scoutfit, wristband and camp clothing

Both participants and staff member always wear their neckerchief and the registration tool provided by the organization on the event grounds. A wrist strap is attached to the wrist and not to clothing or other places of the body. Wristbands are not interchangeable and are only attached once. For a few groups of staff members, it applies that they attach the registration device to their

neckerchief if this impedes the execution of their work due to hygiene or safety. HRM determines which groups of staff members these are, before the start of the jamboree.

7. Smoking

Smoking is only permitted in specially designated locations.

8. Alcohol

- Drinking alcohol is permitted in accordance with applicable Dutch legislation and only at specified locations.
- Sale of alcoholic beverages is only permitted at set locations to participants that are 18 years and older.
- Drinking alcohol by participants, aged 18 and over, is always the responsibility of their own group/leaders. In the event of alcohol abuse or nuisance caused by alcohol consumption, the organization will take enforcement action.
- The participating group is responsible that at least one leader is sober, at all times.
- Participants who are under the influence of alcohol and who are below the legally determined age limit will be transferred by the organization, in cooperation with the responsible supervisor, to their parents/guardians (regardless of the time).
- The consumption of alcoholic beverages by participants 18 years and older is permitted within
 the group's environment in the home atmosphere (or in the immediate vicinity of the group
 tent). Supervision and enforcement of the use of alcohol in the home atmosphere within the
 participating groups are primarily the responsibility of the leaders. Here the organization will
 not maintain unless nuisance is caused.
- It is permitted to discreetly bring alcoholic beverages from outside to the campsite in the daytime for personal consumption in your own tent, by persons 18 years and older.
- The placing of alcoholic beverages in clear view is not permitted.
- It is not permitted to walk around the grounds with open containers of alcoholic beverages.
- Alcohol is served in the staff bar.
- Taking your own drinks to a bar is not permitted.

9. Narcotics

The trading, possession or use of narcotics (including soft drugs) is prohibited during all activities (including outside the grounds) and leads to the immediate removal of the jamboree. In this event the the board of Scouting Nederland and the scouting group will be notified of this removal; for minor members, the parents/guardians are immediately informed. There is no refund of the participation fee.

10. Waste

Waste is disposed of by the participants in the appropriate containers. Pay attention to the pictograms, so that waste can be collected separately. Everything you bring with you to the campsite (such as scenery pieces, tents, and benches), you take back with you. It is not allowed to leave furniture etc. behind. In the event of violations, the removal costs will be recovered from the participating group. Dishwashing water is drained at the designated location and not discharged into the open fields or into the surface water.

11. **Pets**

Pets are not allowed on the property, except for registered assistance dogs.

12. Flags and site decoration

On the grounds, the Dutch flag and the flags of the countries of the foreign participants will be provided by the organization. Flags of companies other than official sponsors of the Dutch Jamboree 2020 and other advertisements are not permitted.

13. First Aid

Participating groups are themselves responsible for bringing sufficient first aid resources and applying simple actions such as placing an emergency bandage, removing splinters, etc. The subcamp staff can and will check this. The organization provides a central healthcare facility that meets the requirements set by the event permit.

14. Fire extinguishers and gas bottles and hoses

Each group has an approved, filled fire extinguisher. This fire extinguisher is within reach. Gas sets, cylinders, and hoses that are used are in good condition and meet the legal requirements. Well before the start of the event, the specific requirements with regard to fire extinguishers, gas hoses, etc. will be shared with the groups. Additional requirements may be imposed depending on the weather situation.

Staff members are advised to have access to a fire extinguisher in the vicinity of their tent. The subcamp staff will check for fire safety, together with the production team.

15. Electricity

It is not allowed to use your own electricity connection on the campsite. It is also not allowed to bring your own generator. There are facilities on site for charging mobile phones.

Participants who have to have access to electricity for medical reasons can submit a request to the organization via info@nj.scouting.nl. The Production heads decide on the applications.

16. Cycling

Participants are not allowed to cycle on the campsite.

Staff members can use their own bicycle only for the performance of their duties. These bicycles are parked in designated places. Staff members are not allowed to cycle on the sub-camps (not even on the staff subcamp).

17. Means of transport and trailers

It is not allowed to enter the site with a car or other motorized means of transport. An exception to this are staff members who receive an exemption for the performance of their duties. Trailers are pushed to the campsite on arrival. Cars, motorbikes, and trailers are parked in the designated places. Participants who come to the campsite by bicycle park their bicycle at the designated location. Bicycles are not parked in the sub-camps.

18. Nuisance

It is not allowed to take along and use equipment that can hinder others (noise, environment, light). Taking and using music installations or large household appliances is therefore not permitted.

19. Offensive behavior

When participants or staff members are seriously disturbed by someone's behavior and feel hindered in their Dutch Jamboree 2020 experience, this will be classified as offensive behavior. This behavior will not be tolerated and action will be taken by the organization. The camp management can decide to remove a participant or staff member from the campsite for offensive behavior. In the case of committing criminal offenses, a report is always made to the police. The national board of Scouting Nederland and its own scouting group are informed in this event. In the case of destruction and/or theft of property of the organization, a report is made to the police. Parents/guardians are immediately informed of minor members.

20. Follow the instructions

In the interest of safety and public order during the event, participants and staff members immediately follow all instructions given by the organization.

21. Additional conditions

The house rules of Scouting Landgoed Zeewolde apply to these camp rules. The licensing authority for Dutch Jamboree 2020 partly determines the course on the campsite. If the permit requires additional requirements with regard to the camp rules, then the camp management is permitted to adjust and/or supplement these rules. Communication about the changed rules will take place via https://nj.scouting.nl/.

Finally

In all cases that do not fall within these camp rules and cause conflicts, the organization team of the Dutch Jamboree 2020 decides. These decisions are binding. The national board of Scouting Nederland and the board of its own group are notified of conflicts and decisions.
